

- **LIABILITY STATEMENTS**

- I voluntarily release and forever discharge and hold harmless LDA from any and all claims or demands for damages, loss of services, costs and expenses, injuries, and any other call for reparation from any and all injury to me or my property arising in any way from my participation in dance classes, camps, performances, the use of LDA equipment or facilities, and any activities associated with LDA.
- I understand that there are risks of physical injury associated with, arising out of, and inherent to dancing. These risks include the potential for slips and falls, sprains, strains, dislocations, soft tissue injuries, musculoskeletal injuries, podiatric conditions, and other risks not specified here.
Understanding these risks and the potential for others not listed, I agree to personally accept and assume all of the risks present in my participation at LDA. My participation at LDA is entirely voluntary, and I choose to participate in spite of the risks.
- Dance education sometimes requires hands-on instruction as well as verbal instruction. Instructors may correct dancers by touching their arms, legs, feet, hips, back and head to move them in the correct position. I acknowledge that this is a common standard in dance instruction and understand that it is my responsibility to communicate clearly with my teacher and/or the director if any form of touch is unacceptable to me.

COVID-SPECIFIC WAIVER SECTION

- COVID-19: The coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is contagious and is believed to spread mainly from person-to-person contact. It is believed that an individual can be infected with COVID-19 without their knowledge and whilst not displaying any symptoms.

- ***In consideration of being allowed to participate in any way in any Liquid Dance Academy activities, I and my child understand, acknowledge and agree to the following:***

1. I certify that my child is able to participate in the program, event or activity, and have not been advised otherwise by a qualified medical professional. They will not participate in any program, event or activity in which they are not physically able.
2. I understand that my child will need to comply with COVID-specific regulations whilst onsite and within our sessions. These include but are not exempt to:
Using hand gel on entrance and being temperature-tested,
Staying within the specific allotted social distancing space
We will be using social distancing methods in order to go to the toilets.
Utilising all social distancing guidelines during all Liquid times and sessions.
3. I and my child/ren agree to comply with any and all new rules, regulations, terms and conditions for participation in the program, event or activity. Including but not limited to cleaning of my hands, remaining in my set space and not bringing un-necessary items to the studio.
4. LDA has put in place preventative measures to reduce the spread of COVID-19. However, LDA cannot guarantee that I and my child or anyone else will not become infected with COVID-19, including my relatives.
5. Participation in a LDA activity could increase the risk of contracting COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child/ren may be exposed to or infected by COVID-19 by participating in a LDA activity, and that such exposure or infection may result in personal injury, illness, permanent disability, and death to myself or relatives. I understand that the risk of becoming exposed to or infected by COVID-19 at a LDA activity may result from the actions, omissions, or negligence of myself or others,

including, but not limited to, LDA employees, volunteers, and program participants.

6. I UNDERSTAND AND VOLUNTARILY ACCEPT AND ASSUME ALL the foregoing risks related to COVID-19 and accept sole responsibility for any injury or illness that may occur. Further, I UNDERSTAND AND AGREE that this release includes any claims based on the actions, omissions, or negligence of LDA, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any LDA program(s), related event, or activity.
7. If a child displays suspected symptoms of COVID-19 whilst participating in any LDA activity, I understand that my child will need to be isolated until they can be picked up by their nominated adult. We will give them our best socially distanced TLC.
8. If I or my child/ren or anyone in my household presents COVID-19 symptoms, or I am contacted by the Test and Trace service, I will inform the staff at LDA as soon as possible, and I will then isolate as advised by the UK government and professional medical services.
9. Me nor my child/ren will not attend if displaying any symptoms of the virus.
10. Me and my child/ren will obey signage in and around the dance space or venues used
11. Ensure my child with symptoms has a test, and communicates with LDA the result of this test.
12. I will pick up a child promptly if they have developed symptoms at LDA.
